Embark - Updated timetable for Australian re-domiciling and NZX delisting

2 June 2023

On 19 May 2023 Embark Education Group Limited (**Embark**) (NZX: EVO, ASX: EVO) announced that its annual meeting would include consideration of resolutions in relation to Embark re-domiciling by listing on the Australian Securities Exchange (**ASX**) and delisting on the NZX.

The Notice of Meeting and accompanying Scheme Booklet included an indicative timetable. Following further discussions with NZX and ASX, a revised timetable for events after the Annual Meeting is set out below:

Delisting of Embark from NZX Main Board following implementation	6 July 2023
ASX trading for New Parent on a normal T+2 basis begins (ASX code: EVO)	6 July 2023
